## Minutes of the Regular Bradford Township Meeting 7:00 p.m. Monday June 12, 2023

The meeting was called to order at 7:00 p.m. by John Hass. Present were John Hass, Bryan Hathaway, Tim Swanson, Brenda Springer, Tom Anderson, Gary Larson, Justin Anderson, Ron Brockamp. Duane Olson, Elise Chester, Stacy Upton, Chuck Nalewaja, Deb Kreger, and Erica Wilson. All rose and pledged allegiance to the flag.

The minutes of last month's meeting were read and approved. The motion was made by Tim Swanson and seconded by Bryan Hathaway.

Elise Chester asked the town board to approve the liquor license for Back to Captain's, Inc. Bryan Hathaway moved to approve. Tim Swanson seconded, and the motion passed unanimously.

Erica Wilson introduced herself as the full-time compliance enforcement official with Isanti County Zoning. She stated there are 30 open cases in Bradford Township. Four on Lake Francis are currently in the court process. After a complaint is filed it can take several months for any action to happen. She said parking issues must be referred to the Sheriff's Department.

Duane Olson had an issue with parking on River Ridge Road. There is also a clean-up issue. Ron Brockamp asked for a slow sign on Navajo.

Three Long Lake residents asked if the township would have objections to the Isanti Soil and Water District improving the looks of the west public access at no cost to the township. The project would also impede run-off into the lake. There were no objections, however the township would want the gate removed. Deb Kreger asked for more 20 mph signs on Bayshore Drive.

The supervisors restated that they are not in favor of using chloride for dust control. It is costly, damages vehicles, and does not last long.

There was discussion of the Isanti Fire Department concerning voting on positions.

The Lake Francis Community Park was discussed. The board will meet on-site on Monday June 19, 2023 at 6:00 p.m.

Justin Anderson stated Seal Tech was finished with seal coating. He, also said the new patching process on 277<sup>th</sup> looked good.

Brenda Springer presented the treasurer's report. Bryan Hathaway moved to approve and pay the claims. Tim Swanson seconded, and the motion passed unanimously.

Bryan Hathaway presented quotes for a Bobcat and an X-Mark mower. There was a motion to purchase the mower but no second, so it was tabled.

It would work for the board to have a meeting with Couri or Ruppe the week of the 26<sup>th</sup>.

Tom and John attended a meeting in Otsego where it was suggested by Attorneys Couri and Ruppe that the board members have email exclusively for township business. Gary Larson explained some options. Bryan Hathaway moved to go with a 3-year option. Tim Swanson seconded, and the motion passed unanimously.

A zoning request by Matthew Chacich was discussed.
