

Minutes of the Regular Bradford Township Meeting
7:00 p.m. Monday May 13, 2019

The meeting was called to order at 7:00 p.m. by Richard Hansen. The minutes of last month's meeting were read and approved. The motion was made by John Hass and seconded by Bryan Hathaway.

Rick Schneider, representing Isanti Spirits, asked for approval of a cocktail license. John Hass moved to approve. Bryan Hathaway seconded and the motion passed unanimously.

There was no objection to the proposed location of a driveway by Lee Englund. The driveway will come off Navajo and along the property of Ray Southworth.

Dale Lewandowski and Mike Barthold inquired about a possible easement off Vale in section 26 that is signed as 291st Avenue NW. Tom will research.

Allan Gummert (763-639-9777) wanted to know if the 50 foot set back applied in a shore-land district.

Richard Stricker asked if the power pole at the north end of Drake Street marks the end of the road. Is the hole in the right of way or on private property? The board will look on-site.

The Popescu letter was tabled.

Brenda Smith presented the treasurer's report. John Hass moved to approve the treasurer's report and pay the claims. Bryan Hathaway seconded and the motion passed unanimously.

John Hass moved to add Bryan Hathaway to the checking account signature card. Richard Hansen seconded and the motion passed with Bryan abstaining. Dale Strike will be removed as he is no longer a supervisor.

Plumbing and heating quotes were received for the Whitetail building. First Choice and D & D Anderson quoted on the plumbing. Dean's Heating and D & D Anderson quoted on the heating. No action was taken.

The board will make an on-site inspection of the cul-de-sac in section 36, Drake Street, 309th and Flamingo, 301st and Flamingo, and Francis Lake Drive on Tuesday May 14, 2019 at 1:00 p.m. Road maintenance, repair, and culvert replacement will be discussed.

Changes to the driveway permit were discussed.

Richard Hansen moved to pay up to \$400.00 per month toward medical insurance for Justin Anderson. Bryan Hathaway seconded and the motion passed unanimously.

Greg Anderson reported on the issue concerning the transfer of building rights within a township on property that is not contiguous. Changing this would require re-opening the comprehensive zoning plan. He also gave a county road report.

Isanti Fire Chief, Al Jankovich, discussed what to do with the old fire truck now that a new one has been purchased.

The meeting adjourned at 9:20 p.m. The motion made by John Hass and seconded by Bryan Hathaway.
